Pennsylvania Equine Council (PEC) Education Grant Program Criteria

The Pennsylvania Equine Council strives to broaden knowledge of equine ownership and management by providing educational programs and materials for equine owners, enthusiasts and the general public. PEC grants are available to support educational opportunities that benefit the horse or the equine industry.

- 1. Grants are offered for educational programs that benefit the horse and the horse industry. Grants can be used to support projects in the following program areas:
 - a. Equine health and well-being
 - b. Environmental stewardship
 - c. Public awareness and understanding of horses and the industry

2. Levels of grants

- a. State-wide: \$500 (program will include participants from numerous locations across the state and will provide a statewide industry benefit)
- b. Regional: \$250 (program will target participants from a smaller region within the state)
- c. County: \$100 (program will target county residents)
- d. Preference will be given to projects and programs developed by county directors and PEC members.

3. How do I apply?

a. Fill out an application and include a one page description of details of the proposed event

4. Sponsorship

- a. PA Equine Council must be listed as an event sponsor on any brochures, agendas, press releases, etc.
- b. The name and sponsorship amounts of any other agencies/groups who are contributing to the funding for this event must be listed on the application
- 5. Events that are not eligible for grant funding include:
 - a. Horse shows or classes in horse shows
 - b. Private programs not open to the public

6. Approval

- a. The review committee will make the final determination on whether the project will be funded
- b. Successful applicants will receive a confirmation letter by email
- c. Unsuccessful applicants will receive a letter explaining why the project did not qualify for funding

7. Payment of grant funds

- a. After the event has been held, a completion report must be submitted. The report must include expense receipts and copies of any media publications such as brochures, press releases, etc.
- b. After the activity report has been received/reviewed, the applicant will be sent reimbursement from the PEC treasurer for the amount granted for the project
